Imported animals will be registered or recorded using the same schedule of fees used for animals born and first registered/recorded in Canada. However, rather than considering the animal's date of birth, the following date will be used to determine the fee charged for registering/recording the animals in Canada.  
***The date of which the registration of the animal was transferred into Canadian ownership at the breed registry office of the exporting country (i.e. the date the transfer of ownership was processed)***  
 The privileged lower rate for registration will be available for three months after the breed association of the exporting country has processed the transfer of ownership. After three months, the higher rates applied to registration of Canadian born animals will apply.
